## Certificate Program Overview

The California Environmental Quality Act (CEQA) is one of California's most significant environmental laws. The law requires state and local agencies to analyze environmental impacts of a proposed project and adopt feasible alternatives and mitigation measures to avoid or substantially reduce significant impacts. It applies whenever a proposed project requires authorization, funding, or is being carried out by state and local agencies. Consultants, developers, planners, local officials, lawyers and other environmental professionals must have a clear understanding of CEQA law, process, and procedures as they work on land use development and planning projects in the state.

The CEQA Practice Specialized Certificate offers individuals a unique opportunity to gain the essential knowledge and practical skills vital to practice in the environment and land use planning sectors. The project-based curriculum allows students to develop a portfolio of work that can be shared with potential employers or clients. Students will link scholarship to practice through case studies, practice simulations, writing exercises, and both individual and group projects.
